Additional Information:

****Copyright and Fair Use-** Copyright is someone's right to his or her work. This goes hand in hand with plagiarism. Fair Use is the copyright law that states under certain circumstances, people have the right to quote and reference someone's work.

Consequences:

The consequences in my classroom are the same for each of the previous rules stated above, both classroom and technology based. We will be using clip charts for behavior throughout the day.

1. The first offense of breaking a rule will be verbal warning and reminder of what our rules are.

2. The second offense will result in moving their clip down and a note to the parent will be sent home. If this is a technology rule being broken then a loss of privileges may take place.
3. The third offense will result in moving their clip down once again and the teacher will make a phone call to the parent/guardian. Student will also lose privileges for technology for the day.
